<u>Public Input:</u> Tax payer asked about size of culvert, and what he had to do to put in a new one. Board will send him an application to fill out and return.

<u>Old Business:</u> Chairman gave the board copies of the report he, put on the Town's Web Site. It covered the topics of Garbage Collection, Blacktopping, Forest Crop Land Removal, Road Improvements, (cleaning ditches) and Road Signage.

He also went through the report from the County for 2018 in regard to the **bridges** in the township. All bridges 20 ft. or longer in length must meet federal standards and are inspected every other year. Inspection is performed by the county and they complete the required report. Reports are filed in town hall if anyone is interested

Job description for **cleaning the Town Hall** was read and discussed. The town is still looking for someone to clean the hall

An updated report was given in regard to our arrangements with **Clark County Humane Society** for stray dogs. Discussed speakers etc. for the Wood County Towns Association the town will host March 15, 2019.

Roads: Chairman composed a letter to send to people who are plowing snow across the road. **State Statues** 346.925 or 346.945(5) says that "Placing Injurious Substance on Highway is against the law.

Equipment: The carbide tips and holders for the grader blades were received, but a cover blade to protect the carbide tip holders was the wrong size. The cover blade will be exchanged for the proper size.

New Business: The clerks and treasurer books were audited and signed.

Chairman completed a form from the county emergency government on Natural Hazards & Preparedness to send back to Wood County Emergency Government.

A worksheet will be designed using Excel, to record financial data from the clerk's records.

Treasurer explained the problems she had on the tax program, The company provided the program corrected the inputs...

Dennis made a motion to pay bills Mark seconded, motion passed. Checks written out were #9165-9183 for the amount of \$262,552.46.
